Federal Electronic Health Record Enhancements in **Capability Block 12**



The Capability Block 12 Release is part of a standard, biannual plan for the Federal Electronic Health Record (EHR) to enhance existing capabilities, introduce new interfaces, and remain current on software code. The release window is scheduled to occur from February 21 to 28, 2025. Department of Defense (DOD), Department of Veterans Affairs (VA), Department of Homeland Security's United States Coast Guard (USCG), and Department of Commerce's National Oceanic and Atmospheric Administration (NOAA) sites that are live with the Federal EHR or affiliated with a live site (e.g., remote services) are part of the release. However, some updates are Department specific, depending on whether the Department uses the platform, capability, or interface included in the release to deliver care at any of their sites. For Captain James A. Lovell Federal Health Care Center (Lovell FHCC), some updates impact only DOD patient care locations (PCLs) or VA PCLs. PCLs refer to the location where care is rendered.

Note: Information is subject to change.
